4. Whystuck will act as the sole mediator between both the parties i.e service provider and customer. Whystuck bargains the price on behalf of the customer and sets the deal at mutual consent of both parties.
5. Customer will pay the charges of the service through online mode to 'Whystuck' . Once received, whystuck will transfer the amount to the respective service providers after deducting Whystuck's commission.
